Vadnais Heights Ballot Question Petition

Regarding the attached Vadnais Heights Ballot Question Petition currently being circulated for signatures:

If a sufficient number of signatures are received, the question of issuing Capital Improvement Bonds to finance a new fire station in an amount of up to **\$54.5 million total, including \$21.2 million in interest** will be submitted for a public vote at the November election, or sooner if the city chooses to call a special election.

Please print the attached petition form and fully complete the required information exactly as indicated, then sign the form. If more than one registered voter resides in your household, each person may complete and sign a petition. Only 10 signatures per petition, under 10 is fine. No additional lines and nothing written on the backside. ***If multiple registered voters live at your address, each person can sign the same sheet.***

Please ask your neighbors to sign as well. State law requires valid signatures from about 5% of the last city election (roughly 500), so we are aiming for 600 to stay safely above the line. Every signature counts!

We encourage you to reach out to family, friends, and neighbors and ask them to participate as well. **Please do not enter any information on the back of the petition form.**
